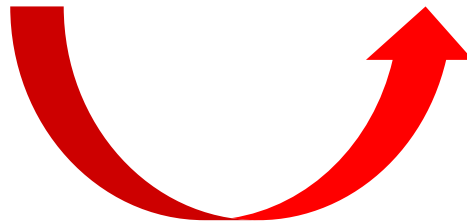

Sector specific rules

Article 18: Meat inspections (DA + IA)

- Definition of "small establishment".
- Adopted by COM on 8 February (DA) and 15 March 2019 (IA).
- Published in OJ on 17 May 2019:

Regulation 2019/624 and Regulation 2019/627

Article 47(2)a: List of animals and goods, CN codes (IA)

- No changes in substance since last year.
- Informal discussions with MS concluded.
- Currently in Inter-Service Consultation (composite products).
- Public feedback mechanism hopefully launched in June.

Article 47(3): Composite products, hay and straw (DA)

- No changes in substance since last year.
- Adopted by COM on 14 January 2019.
- Published in OJ on 25 March 2019:

Regulation 2019/478

- *Current import conditions apply until 21/04/2021.*

Ongoing



Article 48: Derogations from BCP controls (DA) + Article 77.1.a,b and k: Specific controls (DA)

- No changes in substance since last year.
- Informal discussions with MS concluded.
- Currently in Inter-Service Consultation.
- Public feedback mechanism hopefully launched in June.

Article 50.4: CHED accompanying consignments (DA)

- Public feedback ended in March (suggestion to disseminate more information on the practical use of the IMSOC, in particular as regards the CHED).
- Change in substance: Electronic quantity management (IMSOC-CERTEX) only from 2023.
- Adopted by COM on 23 April 2019.
- Awaiting scrutiny by EP and Council.



Article 51(1): Transit and transshipment (DA)

- No changes in substance since last year (but in addition, model certificate for ship supply, including NATO bases are established under Art 77.3).
- Currently in Inter-Service Consultation.
- Public feedback mechanism hopefully launched in June.

Article 52: Details of BCP checks (IA)

- No changes in substance since last year.
- In final stage of discussion with MS experts (29 May).
- Public feedback mechanism launched after the summer.

Article 54(3): Frequencies of physical and identity checks at BCPs (IA)

- No changes in substance since last year.
- In final stage of discussion with MS experts (29 May).
- Public feedback mechanism launched after the summer.

Article 58b: Minimum time for prior notification (IA)

- No changes in substance since last year.
- Voted in PAFF on 26 February.
- Adopted by COM on 16 April 2019.
- Soon to be published in OJ (+ Art 62.3, 64.2, 64.5).

Article 62(3), 64(2) and 64(5): BCP designation (DA)

- No changes in substance since last year.
- Public feedback period ended in February (no comments).
- Adopted by COM on 12 March 2019.
- Soon to be published in OJ (+ IA under Art 58b).

Article 64.4 and 60.2: BCP facilities + listing (IA)

- “Technical vote” in PAFF and public feedback (many comments); change in substance:

The facilities may be used for the performance of official controls and other official activities on consignments of animals intended for export from the Union or which are moved between MS after passing through a third country, provided that the CAs:

- conduct a **risk assessment** of the BCPs demonstrating how the avoidance of cross-contamination can be ensured and they implement the measures identified in the risk assessment for the prevention of such cross-contamination; and
 - ensure a **time separation** between the handling of consignments of such animals and any other consignments of animals entering the Union. During the period resulting from the time separation the facilities used for the handling of consignments of animals shall be cleaned and disinfected.
- Voted in PAFF on 11 April; currently being translated; adoption expected in June 2019.



Article 65.6: Intensified controls (IA)

- Further discussion with stakeholders and MS: Maximum weight limit (300 tons) introduced ("10+10 rule").
- Currently in Inter-Service Consultation.
- Public feedback mechanism hopefully launched in June.



Article 77(1)h: Re-entry into the Union (DA)

- No changes in substance since last year.
- Informal discussions with MS concluded.
- Draft act in final stage after Inter-Service Consultation.
- Public feedback mechanism hopefully launched soon.



Article 77(2): Monitoring transport and arrival of consignments (DA)

- Change in substance: Live animals no longer covered (act to be amended in 2021 if needed).
- Public feedback ended (no comments).
- Currently being translated; adoption expected in June.

Article 90: Model official certificates (IA)

- Including for insects, reptile meat and composite products.
- Adopted by COM on 8 April 2019.
- Published in OJ on 17 May 2019:

Regulation 2019/628

Article 126: Import conditions for food (DA) + Article 127: List of third countries (IA)

- DA includes composite products ("shelf-stable or not").
- Adopted by COM on 4 and 5 March 2019.
- Published in OJ on 17 May 2019:

Regulation 2019/625 and Regulation 2019/626



Article 134 (etc.): IMSOC (IA)

- Consultation with EDPS completed.
- Presentation in PAFF for discussion (animal health on 11 April, plant health on 25-26 April and 23 May).
- Public feedback mechanism hopefully to be launched soon.
- Plan to vote in June or July.

Stakeholders' feedback procedures

- Stakeholders are invited to provide feedback along the policy cycle.
- Structured feedback can be received for draft DA and IA, during a period of 4 weeks, usually:
 - once informal discussions with MS of a DA are concluded, or
 - after the vote of an IA in the standing committee (PAFF).
- Comments received will be analyzed by the Commission services before the act is finally adopted.
